### **REQUIREMENTS:**

- No alcoholic beverages or anyone under the influence will be allowed.
- Cancellations must be with written notification and a \$20.00 refund fee will be assessed. No refunds will be allowed on cancellations 10 days prior to the event. Events are held “rain or shine” and no refunds will be given due to bad weather.
- It is the seller’s responsibility to report and pay state sales tax.
- All vendor booth display equipment, tables, canopies, electrical, etc., must be provided by the vendor. Booths and display area must be clean and attractive. Product must be displayed off the ground. If your space is not left clean, a \$25.00 clean-up fee may be charged.
- Vendor may not set up or place merchandise for sale or exhibit outside their assigned space. This especially applies to OLD TOWN CLOVIS SIDEWALKS, FLOWER BEDS & BUILDINGS. (City of Clovis ordinance)
- Show representatives reserve the right to relocate, move or remove from display any merchandise or equipment they believe to be a nuisance, hazard, objectionable to good taste or not within the realm of the Show.
- The City of Clovis has a “NO PET” ordinance; please leave your pet at home.

### **PLEASE READ THE FOLLOWING AGREEMENT CAREFULLY AND KEEP A COPY FOR YOUR RECORDS.**

Failure to comply with any laws, rules or instructions given by show officials is adequate grounds to immediately terminate this and future event licenses without refund.
