**FEE PAYABLE TO B.O.O.T:** \$25 per night flat fee, or \$20 per night if you sign up for all five. Payment can be made by phone w/credit card; or mail check to B.O.O.T. P.O. Box 1548, Clovis, CA 93613 or call us at 559.298.5774 to arrange payment.

**LENGTH OF EVENT:** 5:30 pm until 9:00 pm. Artist must be set up by 5:30 and cannot tear down until after 9:00 pm.

**LOAD IN & LOAD OUT TIMES:** Setup begins at 4:30 when the street closes. **Please do not arrive or begin to set up before 4:30 pm.** Unload equipment and clear the street of vehicles by 5:00 pm. No vehicles are allowed into the area for load out until after 9:00 pm when it is safe to do so. ArtHop takes place on Pollasky Avenue between Bullard and Fifth Street on the west side of the street. Spaces will be marked with your name so you can find it easily. *ArtHop location is subject to change – we will notify you at least a week in advance if this should occur.*

It is further agreed that this contract is a legal and binding instrument between BOOT and artists and correctly sets out all rights, obligations prior agreements, promises, negations, and any representations not expressly set forth in this instrument have no force or effect and shall be disavowed.

This contract is valid upon receipt of signed contract to the Business Organization of Old Town.

# OLD TOWN CLOVIS ART HOP

## AGREEMENT

In return for the Business Organization of Old Town (B.O.O.T.) considering the application of the undersigned for participation in the Old Town Farmers Market Art Hop, the undersigned Applicant declares and agrees as follows:

Applicant has read and, if this Application is approved, agrees to comply with all Farmers Market Governing Rules and Regulations, (please review online at [oldtownclovis.org/farmers-market](http://oldtownclovis.org/farmers-market)); by signing this contract/hold harmless, you acknowledge that you have read and agree to all Rules and Regulations (whether they apply to you or not) and as may be amended from time to time, and any and all other rules and regulations pertaining to Applicant that may be promulgated by B.O.O.T. Applicant also agrees to a fee of \$25 per night (or \$100 for all five nights if paid together), which goes towards B.O.O.T.'s expenses.

Applicant agrees to indemnify and hold harmless B.O.O.T., the City of Clovis and any Event Sponsors, and all Event Location Property Owners, and each of their respective officers, directors, representatives, attorneys, employees, and agents from and against any and all claims, demands, causes of action, damages (including but not limited to damages to any of the property of any of the indemnified parties), liabilities (including but not limited to liabilities of an indemnified party with respect to their respective officers, directors, representatives, employees, and agents), attorney fees and costs, of every kind and nature whatsoever, whether foreseeable or unforeseeable, directly or proximately resulting from or caused by, or arising in connection with, the participation of Applicant in the Old Town Farmers Market, and/or the use or occupation of the property or facilities herein where the Market is conducted, whether such use or occupation is authorized or not, or from any act or omission of Applicant or any of its officers, directors, representatives, agents, employees, and invitees; and the Applicant shall pay and satisfy any judgment or decree which may be rendered against any of the indemnified parties in any such suit, action, or other legal proceedings; and Applicant shall pay for any and all damages to property of any of the indemnified parties, including loss or theft of such property, directly or proximately resulting from or caused by Applicant, or any of its officers, directors, representatives, agents, employees, and invitees.

If this agreement is signed in a representative capacity, the person signing represents and warrants that he or she is authorized to bind the entity on whose behalf this agreement is executed.
